## **Farm Diversification Purposes**

- Use for the carriage of farm produce including processed produce.
- Park or sports field work and turf supply.
- Fencing work/contracting.
- Verge/hedge trimming.
- Drainage or ditching work for which remuneration is received from water/local authorities.
- Growing trees commercially on the Policyholder's premises.
- Farm Tourism activities: Bed and Breakfast, camping, caravans, holiday cottages, farm hotels.
- Farm recreation activities: farmhouse teas/cafés, farm zoos & open farms, farm tours & museums, country parks/nature trails, equestrian activities, game/clay pigeon shooting, golf course, fishing lakes.
- Direct Marketing of farm produce: farmers markets, farm shop, farm gate sales, farm restaurants.
- Use in connection with the processing of farm produce.
- Use for the maintenance and upkeep of converted farm buildings.

NB. This list of extended activities is only applicable to the agricultural vehicle policy.
